# Submit an "<u>Intention to Submit Proposal</u>" form by <u>Friday, December 20, 2019</u> Submission Deadline for Final Proposals is <u>Friday, January 24, 2020</u>

The 2020 Conference is intended to provide a creative environment where we can "re-imagine", enhance and honor coach education, incorporating the principles of diversity, equity, inclusion and belonging in our work. All topics relevant to Re-Imagining Coach Education are welcome!

# 10 Reasons to Present at the ACTO 2020 Conference

- 1. Presenting at the Association of Coach Training Organizations (ACTO) Annual Conference is an opportunity to share your knowledge, skill and passion about coach education with over 100 participants while supporting and advancing the profession of coaching and coach education.
- 2. You will be part of the ACTO Spirit and Culture, which is devoted to being a strong and committed community of coach educators who are dedicated to advancing the art, science and practice of coaching and promoting the ACTO Stand for Diversity, Equity, Inclusion and Belonging.
- 3. There will be an audience of leaders and influencers in the coach education industry including owners, administrators and faculty members who can share your message with students.
- 4. Your conference entry fee will be waived, which includes all included conference meals, events and presentations (\$725-\$1025 value).
- 5. Your presentation will have a wide international reach as our participants come from around the world.
- 6. You will increase your personal and professional networks.
- 7. Opportunities to present at one of our ACTO Conference Forums in early Spring 2020, describing your presentation and giving a "taste" of what you will be offering at the conference while increasing your visibility.
- 8. As an added benefit, one shared presenter's table will be made available, at no charge, for the display of presenters' select publications, promotional items and business cards.
- 9. Accepted presenters will be eligible to apply for a limited number of transportation grants. These grants (in the form of reimbursement) are intended to supplement the cost of transportation (reasonable and customary) to the conference.
- 10. The conference will be held in beautiful Old Town, Alexandria, VA, 20 minutes from Washington, DC and all the historic, cultural and culinary delights of the region.

#### **Presenter Eligibility Requirements**

- ACTO Members and non-members are eligible.
- Speakers are asked to incorporate the ideals of ACTO's Stand for Diversity, Equity, Inclusion and Belonging in Coach Training in the proposal and workshop.

- Speakers who presented at the ACTO Annual Conference in 2019 are eligible to submit proposals on an expanded or different topic, in alignment with the 2020 Conference theme.
- Presentation material must be eligible to be approved for ICF CCE Units; particularly in the ICF Core Competencies or Ethics categories.
- No fees are required to submit a proposal.
- Only <u>one</u> proposal per person(s) will be accepted.

# General Requirements, Guidelines and Information

ACTO is interested in the expansion and learning of our community, and learning together. We are seeking proposals that:

- 1. Integrate aspects of the theme into specific practices
- 2. Find an aspect of the them that can shift our view of coaching

If you would like clarification or support on how to frame your topic through the lens of diversity, equity, inclusion or belonging, we can offer you coaching or support in this area. \*

# Criteria

The selection Committee will be looking for creative and innovation presentations that address at least one area of coach education, including but not limited to:

- re-imagining the future of coach education from an evolved world view as it impacts marketing, curriculum, faculty, students, etc.
- $\circ~$  the new ICF Core Competencies and ICF Code of Ethics
- self-awareness / self-work
- $\circ~$  responsibility on the global level
- o intersectionality
- $\circ~$  Innovation and disruption in coach education
- technology
- $\circ~$  teaching and learning
- Are reflective of our Conference theme, *Re-Imagining Coach Education: Exploring Diversity, Equity & Inclusion*, and the <u>ACTO Stand on Diversity, Equity, Inclusion and Belonging</u>.
- Are workshop-style sessions that incorporate experiential work for attendees, and provide an experience, ideas or material that will support attendees in their own program or school, staff, faculty, students, curriculum, policies, or other areas.
- Support attendees to explore and enhance their learning within the realm of diversity, equity, inclusion and belonging, at the personal, interpersonal, organizational and/or systemic levels in various topics.
- Demonstrate how your presentation will assist coach educators and trainers in their understanding of coaching and how it applies to our conference theme and the ACTO Stand.
- Design and deliver content to meet the needs of coaching educators and trainers as well as coaching leaders
- Design an innovative, creative and compelling interactive workshop that fully engages this professional audience of seasoned and newer coach leaders, educators and trainers. Provide specific examples of how the audience will be engaged, such as small group discussions on your core topic, exercises to embed the concepts presented, reflection and sharing opportunities.
- Use a short, compelling title that accurately describes the content of your session.

- Clearly demonstrate a balance between content and audience participation. Sessions should be experiential to the greatest extent possible.
- Present a concise proposal that clearly demonstrates the purpose of the proposed program. Make sure to include specific deliverables and not just a broad overview.
- Please note: the ACTO Annual Conference is not a sales or marketing opportunity for your company or yourself during your presentation.
- Before submitting, make sure your proposal is clear and succinct. Also:
  - Proofread for accuracy
  - Complete all requested information
  - Send all attachments
  - o Follow submission guidelines
  - Please submit a video demonstrating the presentation skills of the presenter (preferred) or request an interview with a Committee member. The Committee may also request an interview with you prior to the final selection process. In addition, please submit the contact information: name, email address and phone number of someone that has seen you present.
- Incomplete applications WILL NOT be considered.
- Accepted presenters will each be provided with a Conference Ambassador (a member of the Conference Committee), to answer any questions, provide support before and during the Conference, and to work with you to hone your presentation in any way needed.
- Selections may be made by the ACTO Conference Committee's discretion to ensure quality, expertise and diversity of speakers and programming.
- By submitting an application, you are indicating your availability and willingness to present in Alexandria, VA on June 8-10, 2020. You are also giving your permission to be placed on our conference mailing list (you may unsubscribe at any time).

#### Session Length, Equipment, Presentations, Handouts

- <u>Maximum Number of Presenters per Session</u>: One (1) preferred. We will accept up to three (3). Note that the benefit of one Conference entry fee is to be shared among presenters.
- Length: 90 minutes
- <u>Room Capacity</u>: Rooms will accommodate approximately 150 people.
- <u>Room Set-Up</u>: Chairs will be set around tables. Chairs may be rearranged for your presentation, but MUST be returned to their original configuration by the end of your presentation.
- <u>Audiovisual Equipment provided</u>:
  - o 1 microphone for participants; 1 wireless lapel microphone for presenter
  - Flip chart with markers
  - LCD projector & Screen
  - Laptop & cords
  - Any additional equipment requests are subject to approval by the ACTO Conference Committee and are **not** guaranteed.
- <u>Handouts</u>: The ACTO Annual Conference does **not** reproduce handouts for distribution on-site. However, links to presenter handouts will be posted on the conference website for attendees to download. Presenters may provide hard copies at their **own** expense.

#### **Peer Evaluation**

- The ACTO Conference Committee, a diverse volunteer team of ACTO member coaches, will review the proposals.
- You may get a call from one of the ACTO Conference Committee members to discuss your proposal or be asked to participate in an interview with the committee.
- Evaluation criteria that will be considered:
  - Quality of the information provided
  - Experience and credentials of the presenter(s)
  - Presentation skills
  - $\circ~$  Innovative and experiential nature of the subject matter and session content
  - $\circ~$  Relevance and value to coach educators, trainers and the coaching profession
  - Relationship to the conference theme
  - o Eligibility for ICF CCE Units, especially Core Competency CCE Units
- The Program Committee will notify all applicants of their selection status by March 2, 2020

# **Definitions\***

- The term **diversity** between people can be understood as: the presence of difference. This can refer to people of various races, genders, gender identity, socioeconomic status, sexual orientation, religions, ethnicity, or national origins, mental or physical abilities, and more. When applied to an organization, defining diversity should include cognitive diversity (diversity of ideas) and cultural diversity.
- At the core of **inclusion** is diversity. Inclusion means that people with marginalized identities feel as if they: genuinely **belong**, are valued and relied upon, empowered and ultimately matter. Like diversity, inclusion is an outcome and often an actual experience, one that holds real potential or implications.
- **Equity** is the result of norms, fundamentals, and/or policies that ensure everyone access to the same opportunities. Equity requires preliminary work to identify imbalances, loopholes, or unequal starting places.
- Intersectionality refers to the interconnected nature of social categorizations such as race, class, and gender as they apply to a given individual or group, regarded as creating overlapping and interdependent systems of discrimination or privilege.

**STEP 1:** Read the information above in full.

**STEP 2:** Complete the online "Intention to Submit Proposal" form at this link **INTENTION TO SUBMIT PROPOSAL** as soon as possible. **(By December 20, 2019 at the latest).** 

**STEP 3:** Complete the Presentation Proposal Details below.
