GSAEC Sponsored <u>ICF</u> Marker Training: Oct 17, 2016 - March 2, 2017 including one on-site session to be held on November 10, 2016 at Queens University of Charlotte

GSAEC is pleased to announce our collaboration with the International Coach Federation and Queens University of Charlotte to offer the new PCC marker training for our GSAEC members and related faculty, staff, and affiliate organizations such as ACTO and ICF chapters.

The training consists of a blended format and requires a total of 30 hours of instruction. This GSAEC sponsored training course will include eight hours of onsite training to replace eight hours of the virtual training. The onsite training will be held on the beautiful campus of Queens University of Charlotte. # **Cost and Registration**

Cost: The cost for the course is \$325 USD per participant (non-refundable after October 3). The training is capped at 30 people, so register early to reserve your seat for the marker training! After October 3, registration will be opened to non-GSAEC affiliated organizations such as ACTO and local ICF chapters.

# Q & A

- 1. **Do I have to be an ICF certified coach to attend this training?** No, but you should be familiar with the ICF core competencies. You may attend whether or not you are, or plan to be, an ICF assessor or have an ICF Accredited Coach Training Program (ACTP); participants do not need to hold an ICF credential. Participants should be familiar with the ICF coaching competencies.
- 2. How much time is involved for the completion of the entire course? Approximately 30 instruction hours. See the below Participant Schedule for details including the dates of the live calls and the one day onsite session.
- 3. What will I get out of this training? In-depth understanding of the ICF PCC markers and increased ability to teach toward these markers related to the ICF

core competencies, whether or not you are an ICF certified coach. If you are an ICF certified coach, you can apply to ICF to become an assessor and be qualified to assess in an ACTP program or university-based ICF accredited program.

- 4. Why isn't GSAEC boycotting the location of Charlotte, North Carolina due to House Bill 2 (HB2)? The leadership of GSAEC intentionally chose to approve the training location of Charlotte North Carolina as a demonstration of our support of the city's progressive stance toward gender equality.
- 5. **Ground Transportation:** the airport is about 15-20 minutes from the university and the hotels that will be recommended; the hotels will be approximately 10-15 minutes from the university; it is suggested that you either rent a car or use taxis/Uber.
